- In connection with the separation of the Issuer from Danaher, Restricted Stock Units issued by Danaher on July 15, 2015 to the Reporting Person that remained unvested as of July 2, 2016 were converted into 1,784 Restricted Stock Units of the Issuer vesting in five equal annual installments beginning on July 15, 2016.
