On June 4, 2019, the Issuer granted to the Reporting Person restricted stock units ("Deferral RSUs") of the Issuer in the amount indicated, based on a 20-day average price of \$79.52, pursuant to deferral election made by the Reporting Person of \$110,000 in annual retianer that would otherwise have been paid in cash.
